24. Wisconsin	<ul> <li>15 days (or 25 if seeking contribution from supplier) after service of Notice, contractor shall serve written offer to remedy claim, reject claim, or propose to inspect.</li> <li>10 days after inspection, contractor shall serve notice of any offers to owner.</li> </ul>	• WI ST 895.07
